Terms and Conditions for a St Rocco's Place

By applying for a St Rocco's place in the London Marathon 2027, I confirm that I have read, understood and agree to the following terms and conditions:

1. Participation Agreement

- 1.1 I will be 18 years or over on the date of the event.
- 1.2 I enter this event entirely at my own risk and that St Rocco's will not be liable for any injury, loss or damage sustained whilst participating in the event.
- 1.3 I am physically fit and well and will seek medical advice, if necessary, before participating in the event.
- 1.4 I will let the St. Rocco's fundraising team know immediately if I am unable to take part in the event for any reason. It may be possible to defer your place and fundraising to the 2027 event.
- 1.5 The Event Organisers, London Marathon Events have their own terms and conditions that you will need to agree to separately upon completing their registration.
- 1.6 Any financial costs associated with your entry i.e., transport, accommodation fees etc are to be covered by you and not the hospice.

2. Charity Place Conditions

- 2.1 If you have applied for a TCS 2027 London Marathon ballot place, please accept the ballot place, and inform St Rocco's Hospice so that our charity place can be re-assigned to a supporter that has not received a ballot place.
- 2.2 I cannot swap, sell or transfer my place in the event.

3. Deposit & Registration

- 3.1 On acceptance of the charity place I must pay a **non-refundable deposit of £100** to St Rocco's Hospice within 7 days of accepting the place. Please note that this does not count towards your fundraising total. Once the deposit is paid, we will confirm your place with London Marathon Events. Please note that the full cost to St Rocco's for one charity place is £400.
- 3.2 I must complete my registration with London Marathon Events, for my place to be confirmed. Registration process and completion dates to be confirmed.

4. Fundraising

- 4.1 I agree to raise a minimum of **£2,000** for St Rocco's Hospice.
- 4.2 A minimum of **£500 must be raised by 31st August 2026** in order to retain the place. Please note this excludes the registration fee and gift aid.
- 4.3 St Rocco's Hospice reserves the right to refuse or withdraw an offer of participation in favour of another applicant if the £500 fundraising target is not met by the deadline of **31st August 2026**.



Making Every Day Count

- 4.4 I agree that all monies raised from fundraising activities must be paid to St Rocco's Hospice and must comply with UK Charity Law, Fundraising Code of Practice and St Rocco's Hospice policies.
- 4.5 Donations made to St Rocco's Hospice are non-refundable except in exceptional circumstances at St Rocco's discretion.
- 4.6 Donations must be paid to St Rocco's Hospice via one of the following methods:

- 5.1 St Rocco's will share my story and photos regarding my participation in the London Marathon on their social media channels and I will engage in any relevant activities to support this.
- 5.2 My photo may be published on St Rocco's website, Flickr account and used in future marketing activities. I may withdraw this consent by contacting St Rocco's Hospice at fundraising@stroccos.org.uk

6. Personal Data

- 6.1 Your personal data will be passed over to London Marathon Events as part of the event registration process.
- 6.2 St Rocco's will contact you by email, phone, WhatsApp or post with information in relation to the event and to support you with your fundraising.
- 6.3 A What's App group will be created for participants and relevant staff involved in the event. I understand my phone number will be visible to other participants and St Rocco's Hospice staff within the What's App Group.
